- 2.2 Submit proof of deposit of one-year non-refundable Course Fee of Rs 1,25,000/- (excluding payment gateway charges) in **ESI- Fund A/C No 2**, details for which may be obtained from the concerned Institution, (Submission of proof of deposit via email to [dmc-dl@esic.gov.in](mailto:dmc-dl@esic.gov.in)).
- 2.3 The candidates (upgraded and freshly allotted in 2<sup>nd</sup> round) to submit Acceptance for the seat along with request for Retention of seat **OR** Participation in third round (if any) via email at [dmc-dl@esic.gov.in](mailto:dmc-dl@esic.gov.in).
