1. This order is issued in pursuance of the outcomes of Hqrs. Office Order No. 203 of 2024 dated 31.12.2024, Office Order No. 204 of 2024 dated 31.12.2024, and Office Order No. 39 of 2025 dated 03.03.2025 and in compliance with the orders dated 08.10.2025 of the Hon'ble CAT, Chandigarh in OA No. OA/60/619/2025 – Harsh Jindal & Ors. vs. ESIC.
2. The officials (at Sr. No. 1 to 17, 22 to 24, 31, 32, 38 to 45 and 47) who have already been promoted earlier and assumed the charge on the post of promotion and included in this order, their date of promotion on regular basis shall remain same with reference to the date they had taken charge of the promoted post.
3. Promotion of the officials at Sr. No. 18 to 21 shall be effective from the date of promotion of their respective junior(s) as per DoPT OM No. 22011/5/86-Estt(D) dated 10.04.1989, subject to condition that they have accepted the promotion.
4. Promotion of the officials at Sr. No. 25, 26, 27, 28- 29, 30, 33 to 36, 37 and 46 shall be effective from the date mentioned against their name i.e. the date of issue of respective relevant orders -- OO No. 124 of 2022, 158 of 2022, OO No. 1 of 2023, OO No. 175 of 2023, OO No. 46 of 2024, OO No. 1 of 2025, OO No. 57 of 2025, and OO No. 69 of 2025 respectively, subject to the condition that they have accepted the promotion.
5. The declaration by the officials mentioned in para 3 and 4 above, regarding the acceptance or otherwise of the promotion ordered should be communicated to this office by 26.12.2025. In the

absence of communication, it will be presumed that they have not accepted the promotion and no correspondence in future will be entertained in this matter.

6. The aforesaid officials (mentioned in para 3 and 4) shall exercise their option for fixation of pay within one month from the date of promotion under FR 22(I)(a)(1) and option once exercised will be final.
7. Competent Authority, on the recommendations of Review Departmental Promotion Committee held on 09.12.2025, 10.12.2025 and 11.12.2025 has ordered that promotion granted to 1. Sh. Chander Parkash, UDC vide Office Order No. 211 of 2021 dated 18.11.21, 2. Sh. Kulvir Mahi, UDC vide Office Order No. 158 of 2022 dated 25.08.2022, 3. Sh. Harjot Singh, UDC vide Office Order no. 175 of 2023, Sh. Prabhjot Singh, vide Office Order no. 172 of 2024 be treated as cancelled. Their revised date of promotion shall be effective as mentioned in para 4. Hence their pay shall be re-fixed as per extant rules in due course.
8. The promotion of the above officials will be subject to further orders passed by the Hon'ble Supreme Court in Special Leave Appeal (C) no. 30621/2011 arising out of final judgment and order dated 15.7.2011 in CWP no. 13218/2009 passed by the Hon'ble High Court of Punjab and Haryana and arising out of Hon'ble Delhi High Court judgment dated 23.8.17, OA/1294/2021- Vivek Kumar VS ESIC (CAT Chandigarh) and other related court cases.
9. All above officials are promoted at their present place of posting for the time being only and their transfer/posting order will be issued separately in due course as per the administrative requirement/feasibility.
