Applications are invited for 03 (three) vacancies in the cadre of Insurance Commissioner in Level 14, (Minimum pay Rs. 1,44,200/-) in Employees' State Insurance Corporation on deputation (including Short-Term Contract) basis for a period of 2 years, which can be extended further up-to one year, as per requirement/exigency.

- 2. Eligibility conditions, Educational qualifications, experience & general conditions for the above post are indicated in Annexure-I.
- 3. Eligible officers who are willing to take up the appointment immediately and can be spared after being selected may send their application in advance as per the proforma placed at Annexure-II. However, their candidature for the post will be subject to verification from the application (along with the CCA certificate placed at Annexure-III) to be received, mandatorily, through proper channel i.e. from their cadre controlling authority within stipulated time.

- 3. Applications should reach this office **within 6 weeks** of publication of advertisement in the Employment News.
- 4. Date for determining the upper age limit, qualification and experience will be the closing date prescribed for receipt of application.

- 8. Bio-data / Curriculum Vitae not accompanied by supporting certificates / documents in support of Qualification and Experience claimed by the candidates will not be processed.
- 9. Bio-data / Curriculum Vitae in the prescribed format (annexed with educational, experience certificates/documents etc.) duly certified and stamped by the Employer along with the APARs/CRs (photocopies of each page of APARs/CRs duly attested by an officer not below the rank of Under Secretary to the Govt. of India) for last five years (i.e. 2020-21 to 2024-25 or 2020 to 2024, as maintained), Cadre Clearance, Vigilance Clearance, Integrity Certificate and 'No Major or Minor Penalties for last ten years' Certificate (or a list of major or minor penalties imposed during last ten years, if any) must reach through proper channel to Insurance Commissioner (P&A), Headquarters Office, ESI Corporation, C.I.G. Marg, New Delhi 110002 within 6 weeks from publication of advertisement in the Employment News.
