NOMENCLATURE OF THE PROGRAM:

• Three Month Duration Training Programme in Industrial Health. Upon successful completion of the training program, participants will be granted the title of "Associate Fellow in Industrial Health", accompanied by a certificate.

THE TRAINING PERSPECTIVE:

- The significance of the training program on industrial health for doctors lies in its capacity to enhance their expertise and knowledge, equipping them with the necessary skills to address and manage health challenges specific to industrial settings. The Three-Month Duration Training Programme in Industrial Health will enable Indian Registered Medical Practitioners of Modern Medicine to become medical officers who are considered occupational health physicians in different industrial establishments. Upon successful completion of the training program and passing the final examination, participants will be granted the certificate of Associate Fellow in Industrial Health.
- It is three months duration, full-time, regular, offline training programme consisting of lecture series, laboratory work, practical works, demonstration & tutorial, educational / industry visits, speciality clinical exposure and mandatory project work. The practical, tutorial, and demonstration activities are integral components of the day-to-day course curriculum with the involvement of multiple disciplines including Industrial Medicine, Industrial Hygiene, Safety, Staff Training and Productivity, Human Physiology, Industrial Psychology, Ergonomics etc.

DURATION OF PROGRAM:

• The programme will be conducted from **28.01.2025** to **28.04.2025**.

COURSE FEE:

- Fees for the Training Programme: The selected candidates will have to deposit by online paymentRs. **25,000/-(Non-refundable)** fees for non-sponsored candidates and Rs. 40,000/- **(Non-refundable)** fees for sponsored candidates.

ESSENTIAL ELIGIBILITY CRITERIA FOR ADMISSION:

Candidates fulfilling criteria and in possession of proof of the under mentioned shall only be considered:

- Recognized medical qualification as per the provisions of the National Medical Commission (NMC) Act, 2019and the repealed Indian Medical Council (MCI) Act 1956.
- Internship completion certificate.
- Permanent registration certificate issued by the NMC/ the erstwhile MCI or State Medical Council.
- Minimum Two years working experience (as on the date of publication of the information BOOKLET cum application form) in any establishment or self-certified practice of modern medicine after completion of the compulsory internship period. The period spent on higher studies in the field of modern medicine i.e. recognized postgraduate medical degree/diploma (MD/MS/DNB/Diploma) or an equivalent recognized medical qualification as per provisions of the NMC Act 2019 and the repealed Indian Medical Council Act 1956 shall be considered as working experience.

SELECTION CRITERIA FOR ADMISSION:

Maximum Intake capacity: **30** (may be increased upto 50, subjected to availability of logistic arrangement for comfortable stay and learning facilities).

Provisions of reservation as per Govt. of India rules, regulation and policies for such training programshall be applicable & strictly implemented.

The following objective criteria-based merit list shall be followed for selection to the course. The candidates are advised to lookup the website https://mcalwar.esic.gov.in/ on **07.01.2025** for the list of selected candidates to join the course on **27.01.2025**.

Aggregate marks obtained in the final MBBS as per NMC (Phase I & Phase II) shall be counted for determining the position in the merit list. The marks so obtained shall be converted to a maximum of 100 marks for the sake of uniformity for all candidates.

Candidates who have consolidated marksheet of final MBBS awarded by the Indian Universities as per erstwhile MCI criteria previous to the introduction of phase I & phase II MBBS program shall be included in the common merit list by conversion of the total marks obtained to a maximum of 100 marks.

The marks obtained by the applicant who have cleared the FMGE in the screening test pass certificate issued by the National Board of Examination shall be included in the common merit list by conversion of the total marks obtained to a maximum of 100 marks.

After completion of the compulsory internship period, the following additional marks shall be awarded:-

- 1. **Two (2) mark** will be given for each completed year of working experience in Factory, Mines, Dock Works, Construction Work, and Plantation Work
- 2. **One (1) mark** will be given for each completed year of working experience other than Factory, Mines, Dock Works, Construction Work and Plantation Work or self-practice or period spent on higher studies in the field

of modern medicine i.e. recognized postgraduate medical degree/diploma (MD/MS/DNB/Diploma) or an equivalent recognized medical qualification as per provisions of the NMC Act 2019 and the repealed Indian Medical Council Act 1956.

- 3. **TIE PRINCIPLES** -Wherever two or more candidates have **secured equal aggregate** marks, these tie(s) is/are resolved in accordance with the principles as mentioned below,
 - Priority-1: Age-Senior will be in the upper order of merit, than
 - Priority-2: Date/Year of Completion of the Internship-Earlier the date/year of completion of internship will be in the upper order of merit.
- 4. Two (2) mark will be deducted for each year above the age of 55 years for the applicant.

- <u>List of Non-Eligible Candidates</u> with reason thereto will also be notified/published on the website https://mcalwar.esic.gov.in/ on 10-01-2025.
- Last date for deposition of fees will be **21.01.2025**. The seats for the candidates shall be automatically cancelled andno further representation shall be entertained related to cancellation.
- Seats remaining vacant due to non-payment of fees on or before 21.01.2025 by the first 30 candidates in the merit list will be offered to the wait listed candidate in the order of merit. The list of vacant seats will be uploaded on the website by 22.01.2025. The last date for submission of fees for the waitlisted candidate shall be 24.01.2025 by close of office.

REPORTING & OPEN ROUND COUNSELLING FOR THE VACANT SEATS:

- Physical Verification of the original documents to complete the process of admission shall be made on 27.01.2025 from 09:00 AM up to 01:00 PM for the first 30 candidates (Rank: 1 to 30) as per merit list. Candidates in the waiting list & desirous of enrollment will have to present themselves along with the document for physical verification on 27.01.2025 from 01:00 PM to before 04:00 PM.
- The Course coordinator may consider conducting open round & spot counseling for the remaining vacant seats on 27.01.2025. Instant deposition of fees & personal presentation along with original documents for the aspiring candidates will be must.
- No TA/DA/etc will be provided to attend the document verification/admission/ Reporting/Open Round Counselling or for any other purpose.

NO-OBJECTION CERTIFICATE (NOC)/STIPEND/INCENTIVE/BOND POSTING:

The institute does not have any provision for stipend/incentive/bond posting to training participants. Sponsored candidates by the Govt/ Non-Govt. institutions & industries may avail the opportunity facility provisions as per their employer.

No Objection certificate for the duration of training program from their present employer is a must for all candidates sponsored or declare working in Govt organisation of the Centre or State and have secured enrolment to the training program as per the provisions laid in their employment.

IMPORTANT INFORMATION:

Verification of all submitted copies and submission of required papers with the original document and confirmation of payment of fees, the provisionally selected candidates will be deemed to have secured participation for the Training Program.

- This provisional admission will be granted based on the information/documents furnished by the Candidates as per their application form and during the admission process. In case of any credentials/information/document/certificate etc. being detected or identified or being noticed at any point as false/fabricated/tampered/misleading, his/her candidature and certificate are liable to be cancelled and the fees paid will not be refunded. Appropriate action in this regard will be initiated by the Dean/Head of Office.
- All the participants are required to bring TWO passport-size photograph and one set of self-attested photocopies of all documents/certificates/testimonials including educational & experience certificates along with originals.
- **During the training programme, more than 80% attendance is desirable.** A minimum of 75% attendance is mandatory to appear for final examinations. Attendance will be counted from the first day of commencement of the course. Those who do not fulfil the minimum required attendance criteria would not be allowed to appear in final examinations.

- All participants are required to adhere to the uniform dress code for doctors i.e. White Coat/Apron.
- The expenses towards Food/Stay/Industry Visits/Project Work/Term Work/Examination fees/Lab Reports Books, /Stationeries/copies of study materials/handouts/lectures/ notes and other assignments, etc as part of the curriculum must be borne by the candidate himself/herself/sponsoring organization.
- The classes will be held from 09 AM to 04 PM on all working days (Monday to Friday) & 09 AM to 01:00 PM on Saturday. Participants are expected to devote their full time to the course.
- During the tenure of the course, participants are required to keep track of the different components of the training programme. The Institute will not be responsible if any deadline is missed by the participants.
- Any kind of indiscipline/uncivilized behaviour and use of unparliamentary language in the Institute, hostel, and
 campus shall be dealt with strictly and disciplinary action will be initiated by the competent authority as per
 provision of law.
- There is zero tolerance for any act of ragging performed directly or indirectly by any participants at the institute.

- For any matter related to this training programme, the Decision of the Competent Authority at **ESIC MC & HOSPITAL, MIA Rd, Alwar, Rajasthan 301030** as applicable/appropriate shall be final.

HOSTEL ACCOMADATION:

A limited number of non-family hostel accommodations (semi-furnished) may be available on twin sharing basis in the Hostel of the institute at a **subsidized rate**. The participants shall be allowed to avail the mess & canteen facility of the institute on payment. Only in the rare case arrangements for meals and refreshments may be required to be made by the participants themselves during the course. The programme is non-residential. Staying in the hostel is optional and not compulsory. **Mere selection for the course does not confirm the allotment of the Hostel**. The allotment of the hostel rooms is subject to availability and if available will be allotted **based on selection merit**. **Priority for various categories as per GOI norms** shall be strictly followed in allotment. The decision of the Director in Charge/Head of Office/Estate Officer in this regard shall be final.
