The Competent Authority has ordered the promotion of Shri Ranjan Kumar Tatarway, Adhoc-SSO, SRO-Noida, to the cadre of Social Security Officer/Manager Gr.II/Superintendent in level-7 (Rs.44,900-1,42,400/-) on regular basis on qualifying the Limited Departmental Competitive Exam for the year 2017-18. His appointment on promotion as Social Security Officer is made under section 45(1) of the Employees' State Insurance Act, 1948.

(2) The regular promotion of Shri Ranjan Kumar Tatarway will take effect from 01.07.2023 (i.e. the date of expiry of penalty).

(3) He is promoted at his present place of posting (SRO Noida) for the time being only and his transfer/posting order will be issued separately in due course as per the administrative requirement/feasibility. Consequent upon his joining to the promoted post he will have all India transfer liability.

(4) The pay on regular promotion in level-7 (Rs.44,900-1,42,400/-) will be fixed as per the provisions of FR 22 (I)(a)(1).

(5) The official shall exercise his option for fixation of pay under FR 22(I)(a)(1) within one month from the date of issue of promotion order.

(6) The seniority of the aforesaid official will be fixed as per the extant rules.

(7) Shri Ranjan Kumar Tatarway will be on probation for a period of one year from the date of his regular promotion as per the provisions of Recruitment Regulations, 2007 for the post of SSO/Manager Gr.II/Supdt. and Regulation 5 of the ESIC (Staff and Conditions of Service) Regulations, 2023.
