## Director General's Message

The Employees' State Insurance Corporation (ESIC), India's premier social security organization, steadfastly upholds its mission to deliver comprehensive social protection benefits to eligible workers. Over the decades, ESIC has been pivotal in extending healthcare and social security benefits to organized sector workers covered by the ESI Act.

ESIC in its pursuance of providing comprehensive health care service to its beneficiaries has recruited 1221 doctors in last two months. Further we are in the process of filling 1930 vacancies in the Nursing cadre.

Earlier this year, to reinforce ESIC's healthcare infrastructure and cater to the medical needs of the IPs and beneficiaries, Hon'ble Prime Minister Shri Narendra Modi inaugurated and dedicated 21 ESIC projects worth Rs. 2280 crore, which included medical colleges, hospitals and dispensaries on 25.02.2024.

The provisional payroll data for April'2024 reflects that 16.47 lakh new employees have been added, with a substantial 47.60% belonging to the age group of upto 25 years. The inclusion of 3.38 lakh female members and 53 transgender employees further emphasises our commitment to inclusivity.

During the 232nd Standing Committee meeting of the ESI Corporation held on 19.06.2024 the Annual Accounts 2023-24 of the ESI Corporation was approved.

ESIC observed the 10th International Day of Yoga across all its field offices, hospitals and medical institutions with fervor on 21.06.2024. I also participated in the Yoga Day celebration during my visit to ESIC Medical College & Hospital, K. K. Nagar, Chennai and ESIS Hospital, Puducherry.

## Prime Minister Shri Narendra Modi inaugurated and dedicated 21 ESIC projects worth ₹ 2280 Crore



The Hon'ble Prime Minister inaugurated and dedicated 21 ESIC projects including Medical Colleges, Hospitals, and Dispensaries across the country via video conferencing from Rajkot, Gujarat, on 25.02.2024. These projects, costing ₹ 2280 crore, aim to enhance healthcare infrastructureand services across various states in India.

Colleges and Hospitals in Alwar (Rajasthan) and Bihta (Bihar). Additionally, eight ESIC hospitals in Korba (Chhattisgarh), Udaipur (Rajasthan), Adityapur (Jharkhand), Phulwari Sharif (Bihar), Tiruppur (Tamil Nadu), Kakinada (Andhra Pradesh), and Raigarh & Bhilai in Chhattisgarh were dedicated to the nation. Furthermore, three dispensaries in Neemrana, Abu Road, and Bhilwara in Rajasthan were also part of this initiative.



## 16.47 Lakh New Workers Enrolled Under ESI Scheme in April 2024


The provisional payroll data of ESIC reveals that 16.47 lakh new employees were added in April 2024. Among these, 7.84 lakh young employees, up to the age of 25, constitute the new registrations. The data highlights a significant generation of jobs for the youth, with 47.60% of the total new employees falling within this age group.

The gender-wise analysis of the payroll data indicates a net enrolment of 3.38 lakh female members. Additionally,

53 transgender employees were registered under the ESI Scheme, reflecting ESIC's commitment to delivering its benefits to every section of society.

Around 18,490 new establishments were registered under the ESI Scheme, ensuring social security for more workers.

The payroll data is provisional as data generation is a continuous exercise.







#### ESIC Medical College & Hospital, Faridabad, Achieves Milestone with First Live Renal Transplant



ESIC Medical College & Hospital, Faridabad, has achieved a significant milestone by successfully performing the first live Renal Transplant in an ABO incompatible patient, under the guidance of Dr. A K Pandey, Dean.

Vikas Thapar (IP) received the kidney from his wife and underwent specialized treatment to remove antibodies from his body against his wife's kidney, enabling his body to accept it.



The surgery was conducted by a team of specialized doctors, including Dr. Vimal Bhandari, Dr. Saroj Rajput, Dr. Nishant Gurnani, Dr. Jitendra Kumar, and Dr. Saurabh Joshi.

This achievement marks a breakthrough in the management of patients with End-Stage Renal Disease (ESRD), allowing them to receive kidneys from donors with unmatched blood groups.

The Common Support Mission policy aims to improve ESIS medical facilities by rewarding high performers and supporting those not meeting norms. Mission teams will visit states to evaluate:

- Land and building infrastructure and new proposals.
- Health services delivery against benchmark standards.
- Dhanwantri hardware, data connectivity, and implementation.
- Adequate and trained manpower.
- Availability of drugs, dressings, consumables, and equipment.
- Referral statistics and expenditure.

Headed by a retired ESIC or MoHF&W officer, mission teams will visit states as scheduled. The Regional Director, with DIMS and State Government, must provide necessary data and support, including logistics and coordination.

#### **B.** Programme Implementation Plan (PIP)

The PIP process monitors state performance and links it with future proposals for new or upgraded medical facilities. States must submit annual proposals for new hospitals/dispensaries and upgrades, assessed based on CSM team evaluations and state presentations. Recommendations will be made by the Director General, ESIC, to the Competent Authority.

All DIMS/Zonal MCs/Zonal ICs/RDs should review the policy document and take necessary action.

#### Expansion of ESIC Medical Services and Infrastructure in North East Region and Sikkim



The ESI Corporation, in its 193rd Meeting held on 17.02.2024, has approved the expansion of ESIC Medical Services and Infrastructure in the North East Region and Sikkim as follows:

#### 1. Two Doctor Dispensary:

Initially, 'one doctor' dispensaries with a minimum IP population of 1000 and '100 bedded hospitals' with a minimum IP population of 15000 were approved for North East States. However, in the 181st meeting held on 13.02.2020, the Corporation decided to discontinue 'one doctor' dispensaries due to their inability to meet primary care needs.

Given the low population density in the Northeast, including Sikkim, the requirement of 2000 IPs for two doctor dispensaries and 15000 IPs for catchment areas is unfeasible. Therefore, it is proposed to upgrade all one doctor dispensaries to two doctor dispensaries with a minimum of 1000 IPs. These dispensaries will serve as hubs, providing medical facilities to surrounding areas, including mobile van services. Primary care may also be provided through IMP and tie-ups with PMJAY empaneled private hospitals. The second doctor will be posted based on the needs of surrounding districts. Data on patient footfall will be reviewed, and options like mobile van dispensaries, telemedicine, and mIMP will be considered before implementation.

## 2. Relaxation of Norms for Catchment Area (Medical Infrastructure):

The sparse IP population in the Northeast requires flexible catchment areas, allowing the clubbing of 2-3 districts into one catchment area. If commuting to the HUB dispensary from an adjoining district (SPOKE) takes up to 3 hours or 100 km, doctors from the HUB dispensary will visit these districts regularly to provide mobile medical services. This approach will be supplemented by alternative tie-up arrangements.

Medical and Insurance Commissioners, all DIMS (North East Zone), and Regional Directors are requested to initiate action accordingly.

## Shri Bijay Kumar Das: A Testament to the ESI Scheme's Support


