Candidates will have to bring original as well as copies of documents as given below at the time of Document Verification:

- i. Matriculation/Secondary/Equivalent Certificate.
- ii. Order/letter in respect of equivalent Educational Qualification, indicating the Authority (with number and date) under which it has been so treated, in respect of equivalent clause in Essential Qualification, if a candidate is claiming a particular qualification as equivalent qualification.
- iii. Caste/Category Certificate, if belongs to reserved categories (SC/ST/OBC/EWS).
- iv. Persons with Disabilities Certificate in the required format, if applicable.
- v. For Ex-Servicemen (ESM): **(a)** Serving Defence Personnel Certificate as per Annexure VI, if applicable; **(b)** Undertaking as per Annexure-VII; **(c)** Discharge Certificate, if discharged from the Armed Forces.
- vi. Relevant Certificate if seeking any age relaxation.

- ix. Any other document specified in the Admission Certificate for DV.
- x. Four Passport size photographs.

- xi. Copy of Admit card and Online application.
- xii. Photo bearing identification proof (Self attested photo copy along with original) viz, Aadhar Card/PAN Card/Driving license/Voter ID Card or any other photo identity card issued by the Government.

Further, it should be noted that merely being called for document verification does not confer right upon the candidate for appointment to the post advertised.
